# 1. Bidding Conditions

In accordance with relevant laws and regulations, Lao China Bank Co., Ltd (hereinafter referred to as the "Tenderer") is publicly inviting bids for the "Procurement of infrastructure equipment to support the New Generation Core Banking System project for Lao China Bank" (Project Number: LCNB20240801). This project is ready for bidding and qualified bidders are invited to participate.

# 2. Project Overview and Service Content

- 2.1. **Project Name:** Procurement of infrastructure equipment to support the New Generation Core Banking System project for Lao China Bank
- 2.2. **Tender Scope:** This project involves the optimization and construction of IT infrastructure such as networks, servers, and security for the data center in Vientiane to ensure the smooth operation of the new core banking system of Lao China Bank. This project includes equipment procurement and installation as detailed in Chapter 4 "Technical Standards and Requirements."
- 2.3. Funding Source: Self-financed; funding has been secured.
- 2.4. **Supply Agreement Term:** One year (Starting from the date of contract signing) .
- 2.5. **Quality Requirements:** Must meet the tenderer usage requirements and the technical standards specified in the Bidding Document.
- 2.6. **Delivery (Complete Installation and Commissioning) Time:** Within 60 calendar days of receiving the order.
- 2.7. Free Warranty Period: 3 years from the date of acceptance.
- 2.8. Lot Division: This project is not divided into lots.
- 2.9. **Tender Control Price (including taxes):** Total price is \$550,000.00 (in words: Five Hundred Fifty Thousand US Dollars).

- 3.2. Must have a sound financial accounting system: 2021 to 2023 (Requirement) financial statements (including balance sheet, cash flow statement, income statement (or profit and loss statement or profit distribution statement))

Note: If established for less than 3 years, provide financial status reports from establishment to present; if established in 2024, provide bank credit or funding proof documents.

3.3. Joint bids are not accepted.

- ii. Different units under the same person in charge or with holding/management relationships must not participate in the same tender project.
